## PROJECT TO EVALUATE INTERMUNICIPAL COOPERATION FOR RESIDUAL MATERIALS MANAGEMENT IN BROME-MISSISQUOI TERRITORY Resolution 2023-229

CONSIDERING that the current context of the modernization of selective collection leads us to reflect on the ideal mode of intermunicipal cooperation for the Brome-Missisquoi territory, and this, for all residual material collections;

CONSIDERING the additional workload this will place on existing resources;

CONSIDERING that funding may be available under volet 4 - Soutien à la vitalisation et à la coopération intermunicipale of the Fonds régions et ruralité (FRR) to assess the feasibility of certain modes of intermunicipal cooperation for residual materials management, document their effects and estimate needs;

CONSIDERING the external expertise required to carry out such a mandate in collaboration with regional and local resources;

CONSIDERING that Part 1 - Feasibility and diagnostic studies - allows for a rate of assistance of 50% of eligible expenses, up to a maximum amount of \$100,000;

CONSIDERING that the 21 municipalities of the Brome-Missisquoi MRC wish to submit a project to assess the feasibility of certain forms of intermunicipal cooperation in residual materials

management under Section 4 - Support for intermunicipal cooperation of the Fonds régions et ruralité;

CONSIDERING that Municipality of Brome Village has read the Guide à l'intention des organismes concernant le volet 4 - Soutien à la coopération intermunicipale du Fonds régions et ruralité;

CONSIDERING that Municipality of Brome Village wishes to join the other participating municipalities of the MRC for the project presented for financial assistance and to participate in it;

CONSIDERING that the Brome-Missisquoi MRC is the organization responsible for carrying out the project;

THEREFORE Moved by Pat Panasuk Seconded by Wesley Patch AND RESOLVED

To designate the Brome-Missisquoi MRC as the organization responsible for the project to evaluate the feasibility of certain modes of intermunicipal cooperation concerning residual materials management, to document their effects and to estimate needs;

To indicate that the Council of Municipality of Brome Village undertakes to participate and collaborate in the said project in kind;

To authorize the Brome-Missisquoi MRC to submit a request for financial assistance for the project to the Ministère des Affaires municipales et de l'habitation (MAMH) under the program volet 4 - Soutien à la vitalisation et à la coopération intermunicipale du Fonds régions et ruralité (FRR) Axe - Coopération intermunicipale.

TO authorize the signature of the application or any other necessary document within the framework of the program volet 4 - Soutien à la vitalisation et à la coopération intermunicipale du Fonds régions et ruralité (FRR) Axe - Coopération intermunicipal by the prefect of the Brome-Missisquoi MRC and/or its general manager.

REQUEST FOR MINOR DEROGATION – DM 2023-002 – LOT 4 266 825 (8 WAREHILL) Resolution 2023-230

### NATURE AND EFFECTS

Request for a minor derogation (DM 2023-002) allowing the applicant to proceed with the construction of a residence at a distance of 2.00 meters and 9.00 meters from the side and rear of property lines respectively.

CONSIDERING THAT this request will not cause prejudice to the neighbour;

CONSIDERING THAT this request meets the objectives of the Urban Plan;

CONSIDERING THAT the terrain is irregularly shaped;

CONSIDERING THAT the land to an intermittent watercourse running through its center;

CONSIDERING THAT it is impossible for the applicant to move the building back 9.00 metres without respecting the required minimum distance of 5.00 metres from the septic field;

### OFFER OF SERVICES FOR THE REVISION OF URBAN PLANNING BYLAWS

An offer of services for the revision of urban planning by-laws has been submitted by Gestim Inc. This offer of services concerns the production of a by-law relating to the maintenance of septic installations (tertiary treatment systems for disinfection by ultraviolet radiation).
